



- Benjamin Rush, 1746 – 1813
- Mediziner, Sozialreformer
- Gründungsvater 1776
- Für die Rechte der Frauen
- Gegen Sklaverei und Todesstrafe
- Erstes wissenschaftliches Werk über Alkohol: Trunksucht als schleichende „Krankheit des Willens“, als krankhafter Zwang

- IOGT wurde 1851 in Amerika gegründet

- Wiedervereinigung 1923

- 1964: Organisation statt Orden

- 1965: Cey-Nor gegründet (Erstes Entwicklungshilfeprojekt der norwegischen Guttempler)
- 70er Jahre: Neue Fakten zur Alkoholpolitik
- Heute: IOGT nicht als Abkürzung sondern als Begriff zu lesen



CORNERSTONES OF SWEDEN'S SUCCESSFUL DRUG POLICY



LIFE SET FREE

Background

Drug use in Europe has been expanding over the past three decades. More people experiment with drugs and more people become regular users, with all the problems this entails for already strained national health systems. There are thus suggestions, at the European level, that drug policies have failed to contain a widespread problem.

Sweden is a notable exception.

- Drug use levels among students are lower than in the early 1970s
- Life-time prevalence and regular drug use among students are considerably lower than in the rest of Europe
- Life-time prevalence and regular drug use among the general population are considerably lower than in the rest of Europe
- Drug abuse is ever decreasing in Sweden contrary to the European trend

The Swedish vision

Swedish drug control policy is guided by the vision and the ultimate goal of achieving a drug-free society and the unequivocal rejection of drugs, their trafficking and abuse. Swedish drug control policy is guided by solidarity with disadvantaged and vulnerable members of society. People are entitled to a life of dignity and a society, which safeguards health, prosperity, security and safety of the individual, family and community. Therefore the vision is that of a society free from narcotic drugs.

Overriding task

The overriding task of Swedish drug policy is to prevent abuse. Preventive measures shall strengthen the determination and ability of the individual to refrain from drugs.

International context

The Swedish drug policy is fully in line with the three United Nations Conventions on drugs:

- 1961 Single Convention on Narcotic Drugs,
- 1971 Convention on Psychotropic Substances
- 1988 United Nations Convention Against Illicit Traffic in Narcotic Drugs and Psychotropic Substances

The International Narcotics Control Board carried out a mission to Sweden in 2004 and commended the Government for its commitment and efforts in the fight against drug abuse and illicit trafficking, in line with the international drug control treaties. Sweden has shown that it is possible to combine a modern welfare state with effective methods to prevent non-medical drug use.

Widespread Public support

Public opinion: strong political consensus and support from the public for a comprehensive and restrictive drug policy based on the UN conventions, which include both supply- and demand reduction

The Swedish context

4 contextual factors for successful drug policy

1) Distribution of prosperity:

Income inequalities, which often go hand in hand with criminal activities including drug trafficking, are low.

2) Health literacy:

International surveys show that the Swedish population is particularly health-conscious, therefore less prone to large-scale drug use and inclined to lifestyle choices that promote health and well-being.


3) Employment rates:

Unemployment, including youth unemployment, is below the European average. This reduces the risks of substance abuse.

4) Political commitment and political will:

There's widespread consensus across political parties, civil society, labour unions and the business sector on Sweden's political commitment to a society free from drugs; political leaders continuously express that political will to prevent and reduce harm caused by narcotic drugs remains very strong from both the Parliament and the Government.

- Develop life skills, and self-esteem,

Support Families

- Provide help and support for children of addicted parents,
- Educate parents in crucial issues of youth culture, increasing their understanding for children and young people,
- Provide help and service to women and children who suffer from domestic violence
- Empower women to take charge of their own and their family's fortune, to believe in their capacities.

Strengthen Communities

- Run grass-roots projects in urban and in rural areas where alcohol and other drugs are a major problem,
- Efforts for more environments free from alcohol and other drugs where children and young people also have access to the public resources, to the nightlife and to meaningful leisure time activities,
- Advocate for evidence-based, cost-effective policies solutions.
- Prevention programs that protect children and youth, and reconcile different groups in conflict areas.

DRUGS INHIBIT THE CAPACITIES OF PEOPLE TO BE ACTIVE AND CONTRIBUTE TO THE COMMUNITY.

Develop Societies

- Promote well-being of citizens, economic prosperity and democracy through alcohol and narcotic drugs policy advocacy.
- Population responses to HIV/ Aids epidemic, NCDs epidemic, gender-based violence related to alcohol & other drugs.
- Empower and enable civil society to engage with and contribute to political processes affecting their livelihoods.

DRUGS HARM THE ECONOMY AND ARE GATEWAY TO ALCOHOL ABUSE. THEY ARE RELATED TO CRIME, HUMAN TRAFFICKING, MONEY LAUNDERING AND OTHER BURDENS ON THE ECONOMY LIKE LOSSES IN PRODUCTIVITY AND HARM TO OTHERS THAN THE DRUG USER.




Welche dieser Ziele sind durch Alkoholkonsum beeinflussbar?
